PROPOSED ORDINANCE NO. 23-054

GRANTING A NON-EXCLUSIVE FRANCHISE AUTHORIZING LIMITED USE OF THE PUBLIC ROAD RIGHTS-OF-WAY IN PORTIONS OF UNINCORPORATED SNOHOMISH COUNTY, WASHINGTON TO CITY OF SNOHOMISH

The City of Snohomish, a political subdivision of the state of Washington, has applied to Snohomish County, Washington, for a non-exclusive franchise to construct, maintain, operate, replace and repair sewer and water systems in, on, across, over, along, under, and/or through public rights-of-way within the following portions of unincorporated Snohomish County:

If approved, proposed Ordinance No. 23-054 would grant said franchise to the City of Snohomish, subject to all of the terms and conditions contained in the ordinance.

If approved, the franchise would go into effect following enactment of the ordinance, acceptance by the City of Snohomish, provision of evidence of insurance, and payment of all applicable fees. The maximum term of the franchise would be twenty (20) years from the effective date. At the Public Hearing, the Council may consider amendments to the proposed ordinance.
