AND HEALTH SERVICES TO ASSIST RECIPIENTS OF TEMPORARY ASSISTANCE
FOR NEEDY FAMILIES THROUGH THE WORKFIRST PROGRAM.

WHEREAS, Snohomish County entered into a program agreement with
Washington State Department of Social and Health Services to assist recipients of
Temporary Assistance for Needy Families (TANF) to meet their goals and provide well-
being for their family through the WorkFirst Program; and

WHEREAS, the Washington State Department of Social and Health Services and
the Snohomish County Health Department wish to continue this partnership; and

WHEREAS, the County Council held a public hearing on July 5, 2023, to
consider approving the amendment with Washington State Department of Social and
Health Services and to authorize the Snohomish County Executive to enter into such
amendment in substantially the form attached as Exhibit A;


NOW, THEREFORE, BE IT ORDAINED:

Section 1. The County Council hereby adopts the foregoing recitals as findings of
fact and conclusions as if set forth in full herein.

Section 2. The County Council hereby authorizes the County Executive, or
designee, to execute the amendment between Snohomish County and Washington

This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

1. The period of performance is extended through June 30, 2025.
2. The Contract Maximum Amount is increased by \$14,300. The new Contract Maximum Amount is \$17,875.
3. Section 4. Consideration. is amended as follows:

Total consideration payable to Contractor for satisfactory performance of the work under this Contract, shall be paid in accordance with the fees set forth in the attached Exhibit(s).

Total consideration payable for the contract period to the Contractor for satisfactory work performance including any and all expenses under this Contract is up to a maximum of \$ 14,300.

Unspent funds designated for any State Fiscal Year shall remain unspent and may not be carried forward into the following State Fiscal Year.

Consideration payable per State Fiscal Year:

State Fiscal Year 2023 (July 1, 2023 through June 30, 2024) = \$ 7,150

State Fiscal Year 2024 (July 1, 2024 through June 30, 2025) = \$ 7,150

All other terms and conditions of this Contract remain in full force and effect.
