<b>Type:</b> ⊠Contract □Board Appt. □Code Amendment □Budget Action □Other	<u>Scope:</u>	This ordinance consists of an interlocal agreement with the transfer of County interest in 64 <sup>th</sup> Street NW to the Tulalip Tribes and authorizes a quit claim deed, to transfer 64 <sup>th</sup> Street NW to the Tulalip Tribes, so that the Tribes can operate and maintain 64 <sup>th</sup> Street NW for continued public use as part of the Tulalip Tribes' Tribal Transportation Program, as negotiated and provided under RCW 39.33.

**Duration:** The Agreement shall be effective upon signature and authorization by both parties. The document will continue in force unless both parties mutually consent in writing to termination.

**Authority Granted:** Authorize the County Executive to execute an interlocal agreement, substantially in the form of Exhibit A to the ordinance, with the Tulalip Tribes for the transfer of 64<sup>th</sup> Street NW; and upon full execution of the interlocal agreement, the County Executive is authorized to execute a quit claim deed, substantially in the form of Exhibit B to the ordinance, to transfer 64<sup>th</sup> Street NW to the Tulalip Tribes. Interlocal Cooperation Act, chapter 39.34 RCW authorizes the County to enter into such an agreement.

**Background:** In 1986 the US Department of the Interior granted a right-of-way easement for a public road over 64<sup>th</sup> Street NW to the Bureau of Indian Affairs which provides for "right privilege, permit and easement to construct and maintain easement for public road forever". Snohomish County Public Works currently maintains 64<sup>th</sup> Street NW as part of the County Road network. The Tulalip Tribes wish to improve and maintain 64<sup>th</sup> Street NW as a public road as part of the Tulalip Tribes Tribal Transportation Program (TTP). Snohomish County and the Tulalip Tribes have negotiated an ILA under RCW 39.33. The ILA will allow for the transfer of real property rights for 64<sup>th</sup> Street NW from the County to the Tulalip Tribes. Under the ILA the County will be relieved of future costs associated with maintaining 64<sup>th</sup> Street NW, which is in the best interest of the public.

**<u>Requested Action</u>**: For Council to move this to GLS on March 27, to set time and date for a Public Hearing, suggested time and date of April 17, 2024, at 10:30 am.
