<u>Authority Granted:</u> Approve the 2024 Historic Preservation Grants attached hereto for funding at the recommended levels as set forth therein and authorizes the Director of the Department of Conservation and Natural Resources signature authority to sign the grant agreements on behalf of Snohomish County and any other documents necessary to effectuate all the terms and conditions of said grants agreements.

Background: RCW 36.22.170 establishes that one dollar of every document recorded by the county auditor will be designated to the promotion of historic preservation. Ordinance 08-119 establishes funds to authorize the County to administer a Heritage Preservation program to allocate revenues accruing under provision RCW 36.22.170. The County Council created the Historic Preservation Grant Program to provide local assistance in collection, preservation, and interpretation of Snohomish County's heritage. The Snohomish County Historic Preservation Commission established grant criteria and an application process to distribute the funds through the heritage community and received applications for program assistance from various heritage preservation organizations in response to a public solicitation for applications.
