I am writing to implore you to NOT go down the road of a complete fireworks ban! Instead, I want to share a unique perspective and idea on the fireworks question currently being discussed in Snohomish County. I think you will find the information below to be a fresh perspective that has shown great results and **increased safety** in many communities in our region!

This structure, a Modified Fireworks Ban, is an out-of-the-box option that many people are not aware of when it comes to decreasing stress and danger related to fireworks, and increasing peace and safe celebration. It is possible to do all of the above!

I recently retired from a teaching career and took a job as the area manager for a fireworks company. In that role, I get to support non-profits in having successful fundraisers so that they can continue the good work they are doing in communities. However, once I took this job, I began responding to many municipalities grappling with the fireworks question. Interestingly, the communities I am working with are trying to figure out what to do because the bans they have had in place for years simply are not working, and in fact, they have found that they make the issue worse, so they are looking for alternate solutions.

What I am sharing with them is a Modified Fireworks Ban, something that many communities have found to be very successful in minimizing the fireworks concerns expressed in pretty much every community – loud booms that scare pets, children, veterans, etc., and fireworks that fly and have the potential to set fires. This model has been shown, both by data and anecdotally, to make a huge difference in those areas, and more and more communities are turning to this option as an alternative to their bans that have not been successful.

A Modified Fireworks Ban does the following. It is a WIN-WIN-WIN situation for all facets of communities grappling with the fireworks question.

- 1. Aerial fireworks and those that product a loud report (boom) are completely banned.
- 2. Sales of ground-based fireworks (Items that stay on the ground with nothing going up in the sky and nothing making loud booms) are allowed to be sold. These include fountains, which have a solid base on the ground and provide a display from there. Nothing is shot into the air. Also allowed are novelty items, the kid items such as snakes, tanks, etc. that stay on the ground. Statistics have shown that this category of fireworks is rarely involved in fireworks problems.

This is a WIN-WIN-WIN in the following ways:

- 1. For those concerned about danger of flying fireworks and noise, those items are completely banned and are not sold.
- 2. For families and others wanting a way to purchase safe fireworks, and to celebrate with fireworks in legal areas, those items are available. They do not have the option to purchase aerials or loud items.
- 3. For non-profit groups, the fundraising option is still available to them, allowing them to continue doing the good work they are doing in the community.

In addition, communities who have implemented this option have found that less of their populations go to tribal land, where the availability of highly dangerous items is prevalent, thus bringing less of them back to the community. One community found that 90% of their residents said they shop at the closest fireworks site. In that way, the city had strong control over what 90% of people purchased.

I would love to share more with you about this idea and the statistics shown by communities who have implemented this plan. The City of Tukwila is one such city who switched last hear from a total ban, which they had had for 25 years, to a Modified Ban as described above. They found that they had the least number of calls for service in over 20 years, and \$45,000 was raised for non-profits. Because of stories like this, I am committed to working hard to help prevent communities from going down a path that other communities are finding simply does not work, and often makes things worse since people no longer have an accessible option for buying safe fireworks. I will continue to help currently banned cities to move to a modified ban, and hopefully help other communities to not go the way of a full ban.

I am available to share any supporting information that you may be interested in, or to help in any way possible. I would love to chat sometime, either virtually, by phone, or in person, if you would like to know more about this unique option. This is my passion, and I hope I can be of help as your county examines this issue.

Thank you so much for the time and effort it takes to be in the role of Council Member and to look hard at such challenging issues.

On the 4th of July, I can't go anywhere for fear of my home and 3.5 acres of woods will be set on fire by some of my neighbors who drink and whoop it up with huge illegal fireworks displays. I just have to sit here and endure. It's horrible!

If we have a fire, I'm not sure that I, nor some of my neighbors would be able to get safely out of the blazing woods.

The only help I get from the fire department is their printing up flyers for me to take/walk around to my neighbors. Last year I left 250 flyers on front porches. The Fire Station in my neighborhood has a very small sign banning fireworks that they put out by the road. It is flimsy and folds upon itself and really can't be read. I'm not sure why the fire department is so shy about following through in a meaningful way in support of the fireworks restriction.

The sheriff's department is overwhelmed and isn't able to respond to the many calls for help.

For the past 61 years, I have owned 3.5 acres of forest that is part of a forested ridge-line above Swamp Creek. I have been preserving this property as it is critical to the storing of water runoff that feeds Swamp Creek in the summer. It is inhabited by many variety of birds and small forest animals.

Please redeem yourself and our Urban Growth Area by revising the Fireworks ban legislation to require that fireworks not be sold where it is illegal to set them off. The legislation passed a few years ago by this body was a total sham and has caused more distress among neighbors who thought they had the law on their side. Now we have Churches selling fireworks and little old ladies like me walking flyers from the fire department around neighborhoods begging people to not shoot off fireworks.

It is critical that you help preserve our forests, birds, and stop the traumatization of citizens and their pets.

Mr. Countryman is <u>wrong!</u> The Council made a huge mistake tabling Ord. 23-057 as advocated by Mr. Low. I was the person Mr. Countryman referred to who made the public request for fireworks information in 2022. No information was provided because there is no information other than the Sheriff's Department has no records of issuing any fireworks citations in 2022.

There is no need for another hearing or more study to halt the sale of fireworks that are already illegal under County Code. RCW 70.77.250(4) only applies to fireworks use, not fireworks sales. Adopt Ordinance 23-057 effective immediately on June 28, 2023 to take effect on June 28, 2024, not 2025. The Council's action to table ORD. 23-057 will just continue the problem needlessly for another year and is based on the incorrect opinion provided by Mr. Countryman.

There also appears to be some misunderstanding by some of the speakers at the Planning Committee meeting today. All fireworks use is currently banned in most of south County. Ord. 23-057 will only <u>ban the sale</u> of fireworks where their use in areas where they are already banned. No consideration should be given to a modification to the current ban on the use of fireworks. Under no circumstances should the County Council consider reinstating the use of fireworks in the south County UGA.

I am pleased to speak in favor of County Ordinance 23-057, that will ban the sale of Fireworks in those areas of Snohomish County where their use is currently banned by County Code.

Last July we saw an unprecedented use of fireworks in the banned areas of unincorporated Snohomish County; 2022 fireworks use was even greater than before the ban was established. Why?

Because the County Code illogically allows the sale, but not the use of fireworks in banned areas. What the heck do you think people are going to do with fireworks after they purchase them? They cannot light them off in State or Federal forests and they are banned in every City in the County. People simply ignore the law and light them off on County streets.

The current code allowing the sale of fireworks is untenable. Allowing the sale, but not the use of fireworks, is like allowing the sale, but not the use of Heroin. There is absolutely no enforcement by the Sheriff's Department on the use of fireworks in unincorporated Snohomish County; in 2023 the Sherriff's Department gave out zero fireworks citations. Salespeople at the Shock-n-Awe stands know this and even tell customers that the Sheriff's Department does not enforce the ban so feel free to use them.

Besides the obvious safety, fire hazard, PTSD, nuisance noise, air quality, and pet issues, fireworks also pose a threat to our streams from sulfur compounds/heavy metals burned to make the brilliant colors that washes off County roads. A 2009 County report documented an increase from fish harming Perchlorates in our waterbodies after the 4<sup>th</sup>. Perchlorates are commonly used as an accelerant in fireworks.

County staff are wrong, stating that this ordinance will have no real effect until 2025. Currently County Code 30.53A.716 does not allow the sale of fireworks before noon on June 28th, so this ordinance if adopted before noon, June 28th this year will be in full effect for next year.

Banning the sale of fireworks will go a long way to reducing their illegal use in Snohomish County.

Thank you, Councilman Peterson, for introducing this much needed ordinance.

I urge the Snohomish County Planning and Community Development Committee to approve Ordinance 23-057, relating to fireworks, amending Snohomish County Code Section 30.53A.710

There is no enforcement by the Sheriff's Department on the use of fireworks in unincorporated Snohomish County; banning the sale of fireworks will go a long way to stopping the illegal use of fireworks, where banned in Snohomish County.

I also want the Planning Commission to ban fireworks countywide. The SC 2019 fireworks advisory vote was very disingenuous. 52.55% of the County voted to ban fireworks for the entire County. Yet rather than listen to their constituents, the SC Council cherry-picked a few unincorporated areas near large cities to ban with most of District 5 unprotected. Sam Low stated his District did not vote to approve the ban, yet there was no mention the decision would be limited by District when we voted. Why is SC reluctant to ban fireworks completely? King County didn't hesitate. If it's donor money from fireworks sales, give them what they usually make rather than endangering SC citizens with catastrophic fires. It would be far cheaper.

Additionally, limiting the ban's entirety is confusing and leaves the rest of us to suffer a potential wildfire catastrophe. Most of us in District 5 are in the Wildlane Interface Zone and pay \$32/year in additional property tax to assist our local fire districts, which must travel gridlocked highways to get to our 340 homes with just one entrance/exit should fire occur. Climate change is real – my homeowner's insurance sent me a notice confirming my potential for fire danger this year. How long will it be before our insurance companies refuse to renew policies because of this, like in California, Florida, etc.?

With KC's complete ban based on a 100-signature petition, those of us in unincorporated SC District 5 are the main area where it's "legal," meaning those in banned zones will now more than ever come to our location to shoot off their fireworks. I urge the SC Council to reconsider and immediately invoke a complete ban. I know it can only go into effect next year, but the Fire Marshal and Dave Somers can invoke an emergency fireworks ban if we have continued drought.
