<u>Carol Welch North Wellington</u> • <u>22 Oct 21</u> "Discharge of fireworks in unincorporated Snohomish Co. On Saturday evening 10/16 a (newer) neighbor decided to discharge fireworks while I was bringing my 3 horses into the barn for the night, at 8:30pm. Their backyard is separated from my barn by a very narrow backyard of another neighbor. My horses were just about to enter the barn, with me directly behind the last horse, when the "show" started. In their surprise and panic, I was knocked to the ground but avoided being trampled by rolling under a fence. In the short breaks between discharges, I managed to get them into their stalls (it helps that they knew there was hay waiting), went outside to the front of the barn and literally screamed at the top of my lungs in-between discharges to STOP IT NOW. They didn't stop. My horses were very scared, this was far louder and closer than they are used to, not to mention I do alot of prep prior to EXPECTED fireworks (on 7/4 and 12/31) to mitigate noise and visuals (including tranquilizers). I quickly drove to the neighbors, and interrupted their party (yes, with my hair on fire....). The repercussions of this event is 1) my younger horse whose stall window (un-shuttered at the time) was exposed to the visual explosions, will not willingly go into her stall now, and panics when she is in it, (sadly a place where she used to feel the safest); and 2) I have a black-purple bruise and knot

the size of a grapefruit on my hip. I could have been very badly hurt, or worse (BTW, I'm 65yrs old, have had horses for 53yrs, and at this home specifically for the past 28+yrs). ..."

"...And when trying to soothe a petrified, sweat-soaked, 1200lb horse with my arms around his neck, trust me.... it's hell. I haven't enjoyed a July 4 friends and family event at my home in 20yrs, as the pyro has gotten worse and worse. Celebrate the 4th? Not at my home....only celebration is when it stops. "

"Gosh, that was so dangerous to you and your horses. I'm so sorry that happened. You may already know, for unincorporated King County, our council passed a ban on fireworks this year to take effect in 2022. Two individuals shooting off mortars and rockets for hours, causing harm and terror thru our neighborhood of 100s of homes, full of families with new babies and seniors, pets and a few horses, tired and healing people, and many working diligently from home. Editorial: Heed south county fire officials on fireworks ban | HeraldNet.com Following the Continental Congress' vote in July 1776 in favor of the Declaration of Independence, Founding Father John Adams wrote his wife Abigail that the day should be celebrated each year with "pomp and parade ... games, sports, guns, bells, bonfires and illuminations from one end of this continent to the other."

Regarding the "bonfires and illuminations," we're guessing Adams wasn't having to pay much of a premium on his homeowner's insurance, otherwise he might have had a different opinion regarding fireworks, at least those in the hands of his neighbors.

Many Snohomish County residents, however, do have to consider insurance payments and the risk for fires, the nuisance of noise — especially for pets — and other impacts from the annual flash, boom and sizzle of consumer fireworks in our Fourth of July celebrations.

A frequent topic of discussion and proposed ordinances for the county and local cities has returned with a petition to the Snohomish County Council from Sound County Fire officials who want the council to bar the sale and use of fireworks in neighborhoods outside of city limits of Everett, Lynnwood and other south county cities, as The Herald's Noah Haglund reported Sunday. The neighborhood bans require a petition of 51 percent of registered voters in neighborhoods of 50 or more homes or an area of at least a square mile. To date, the county has received no such petitions, but the ordinance also allows for fire districts and authorities to submit the request. Page 3 of 6

The county council has schedule the issue for its June 26 meeting and could set a hearing in coming weeks. Even if adopted, the ban wouldn't take effect until 2021's July 4 celebrations; state law delays implementation of such ordinances for a year if they are more restrictive than state regulation.

The ban would not apply to unincorporated areas in the north end of the county.

The issue of fireworks and whether to ban their sale and use pits issues of safety and nuisance against, well, liberty and the pursuit of happiness. It feels a bit antithetical to ban fireworks for the Fourth of July, but there are legitimate concerns regarding their use, legal and illegal. Reports of missing pets can increase 40 percent during the fireworks season.

South County Fire, going back to 2005, has tallied \$3.7 million in property damage from fires caused by fireworks. And 262 injuries were reported statewide in 2017, most around the July 4 holiday, to the Washington State Patrol.

And awareness has increased in recent years that fireworks can cause anxiety for those with posttraumatic stress — including combat veterans — and the victims of gun violence.

Fireworks use is in the unincorporated areas of the county are currently limited to the hours of 9 a.m. to midnight on July 4. About half of Snohomish County's cities have banned consumer fireworks outright. The others, including Arlington, Bothell, Darrington, Granite Falls, Index, Lake Stevens, Monroe and Snohomish, have regulations similar to the county; Stanwood and Sultan have no restrictions beyond state law.

Another county ordinance in 2016 gives the county fire marshal the authority to declare an emergency and ban fireworks during periods of extreme drought. Currently, Editorial: Heed south county fire officials on fireworks ban | HeraldNet.com low snowpack and a warmer and drier spring have resulted in moderate drought conditions in Snohomish County and much of Western Washington.

Fireworks bans and regulations are a challenge to enforce, but a ban on their sale would make them more difficult to acquire, which could limit their use.

In recent years, the county council has stopped short of a countywide all-out ban on fireworks, instead leaving the option available to neighborhood majorities and fire officials.

Jim Kenny, board chairman for South County Fire, noted in seeking the ban the extent and growth in the areas the agency is expected to protect from fires and injuries.

"That makes it very challenging and very dangerous to use fireworks amongst so many homes and so many people," he told The Herald.

The council should take seriously the expertise and knowledge of fire officials and extend a fireworks ban in the south county's unincorporated areas as requested.

Some will protest the ban, but it doesn't have to mean a less enjoyable Fourth. Along with professional fireworks displays, a ban on consumer fireworks would still leave us with Adams' pomp, parade and more.

Thanks for writing.

This is an issue that popped up as of last week when the press reported on the meeting you attended. I have begun to look into this as it's a new issue for me. Unfortunately, I will not be able to attend the meeting in Everett tomorrow.

What I have found out thus far is that:

1 This issue was discussed in past years at District 7 with the previous board and that they decided to not take a stance. Given the interest by our constituents, I am sure our new board will be discussing this issue in future meetings. Realistically, I don't think there is time for us to have a debate and vote before July 4th, 2015 based on meeting schedules.

2 As fire districts, we have no enforcement capabilities or legal standing to enact a ban or enforce it. We of course deal with the increased call volume during the 4th and the fires.

3 From speaking with folks at the county, it does not appear that this policy issue is scheduled for any hearings, agendas or work sessions. Tomorrow's meeting is the General Session so I think it will be a chance to speak on any issue for the 2 or 3 minutes they allow.

Even if it's not this year, focusing on a council vote to enact a ban is probably the best avenue to achieve your goal. You will need to get one of the council's committees to put it on their agenda for action.

4 The Sheriff does not have the deputies required to enforce a county-wide ban and that is the main objection at the county level.

You are completely right that this is likely to be one of the worst 4ths in a while with regard to fire danger. We just got alerted last week to the potential wildfire danger this year. Our firefighters are part of a regional effort to fight those types of fires and for events like Oso. It is a serious problem that affects District 7 directly.

I hope this information helps in some way.

Good Afternoon Commissioners and Fire Chief - I attended Fire District 1's Commissioner meeting last evening to support their resolution requesting the SC Council ban fireworks in unincorporated SC. They approved and plan to present it to the Council at 9am on June 24th. However, I was told the resolution only includes District 1, not the entire County and is not enforceable until next year.

We need to do both - stop fireworks this year and provide a permanent fireworks ban for all SC's unincorporated areas. 2015 is horrific. We're facing a combination of extreme fire danger and severe drought with the introduction of fireworks exponentially increasing the probability of catastrophe for all residents. Additionally, July 4th falls on a Saturday for the first time in 6 years with the potential to be worse than the banner fireworks fire year of 2009.

Therefore, I am writing to request

- 1. Your support of Fire District 1's resolution, that it include District 7 and that you plan to send a representative to the SC Council Meeting on June 24th
- 2. Most importantly though, request the Snohomish County Council petition Governor Inslee to declare a state of Emergency under RCW 38.52 banning the sale/discharge of fireworks statewide effective immediately and through the remainder of 2015 due to extreme fire danger.



William Lider Public Comments to County Council June 28, 2023

I spoke at the June 20 Planning Committee meeting, along with a number of other concerned citizens in support of Ord. 23-057, where the Council chose to delay for another year banning the <u>sale</u> of fireworks in Snohomish County, where their use is already illegal use. We were all shocked by the Council's vote to delay and study this ordinance. As I stated in my previous communications to the Council, no documents were provided to me on past public records requests on fireworks for responses or citations by the Sheriff Adam Fortney's Department. A delay looking for more records is meaningless, as the records either do not exist; or if they do, then there has been a serious violation of the Public Records Act by the County for withholding public records to my previous request.

The Council can vote today to take emergency action pass and pass Ord. 23-057 banning the <u>sale</u> of fireworks effective June 28, 2024 in south County, where their <u>use</u> is already prohibited. If the Council fails to act today, the <u>sale</u> of fireworks in unincorporated Snohomish County cannot be halted until the year 2025, two years from now.

I again request that the Council vote today and each Councilperson go on record as either supporting or opposing the sale of fireworks where their use is already illegal. Because there is no enforcement, fireworks use was greater in 2022 than at any time since the fireworks ban became effective in 2020. Either:

- 1. Vote on an emergency ordinance to ban fireworks sales effective June 28, 2024; or
- 2. If the Council is unwilling to vote on an emergency ordinance to halt fireworks <u>sales</u> in 2024, then it should raise the fine for using fireworks that are already prohibited in south County to a gross misdemeanor with fines of:
 - a. \$1,000 for the first fireworks citation; and
 - b. \$5,000 for any subsequent fireworks citation.

Increased fines for fireworks <u>use</u> should take effect immediately as a deterrent for the illegal use of fireworks in south County.

Raising the fireworks citation fine does not require the 1-year delay to take effect under State law, because the use of fireworks is already prohibited in south County. A higher fine for illegal use might give the Sheriff Adam Fortney's Department some incentive to enforce the law, rather than treating it as a barking dog complaint. An emergency ordinance is warranted given the current fire danger in Snohomish County and because currently there is no enforcement of the fireworks ban by the County. Fireworks use is greater now, than it was before the ban took effect in 2020. Fireworks vendors tell their customers that is ok to use fireworks, because they know that Sheriff Fortney does not enforce this law.

One year's notice is more than enough time for the churches to find alternative ways to <u>legally</u> raise money, rather than profiting off fireworks sales that can only be used illegally. It is the height of hypocrisy to allow the <u>sale</u> but not the <u>use</u> of fireworks in my neighborhood. Fireworks sales begin at noon today, where they are already illegal to use. Please do something today!

I was very saddened to see that in the last issue of the South County Fire District's newsletter didn't mention the fireworks ban in South Snohomish County.

I have a hard time with this, because so many people petitioned the County Council at the hearings a few of years ago. But even our own fire station at Hilltop on Damson doesn't put out much of a message so that residents can see and believe that there is really a fireworks ban. I have the feeling that those in power really don't care. Please show me that I am wrong.

For the last 2 years the fire station on Damson Road in my neighborhood had a little flimsy, cloth or plastic, sign that they put by the road that was about 3 feet off the ground and about 3 feet wide and about a foot and a half tall hanging on the posts. It was hard to see and folded over on itself so you couldn't read it any. It said something about the fireworks ban

I am so disappointed in our South County Fire Department for not working as hard as some citizens, including myself have. It may seem that the fire department has done a good job, however I beg to differ from you. I am the only one in my large community who has ever taken flyers around. The Hilltop Station does not post the fireworks ban is such a way that people can see it. There is not notification or any other public information coming from them. The last issue of the fire department flyer did not even mention the fireworks ban. I am a daily reader of the Herald. The fireworks ban should have been on the front page. Nothing there either.

80% of the neighbors I have talked to are afraid of fireworks, but they are afraid of their bully neighbors who continue to light off fireworks. Most people think that since fireworks are still allowed to be sold that they can be lit off. I never see any firemen at these sales telling people about the ban.

The law is a sham. Our County Council should be ashamed! Has the fire department made any effort to get the sale of fireworks removed from the law. I doubt it.

I am sorry to come off this way, but it appears to me that what is really happening out here in unknown to the fire district.

Michelle,

Though I understand the stress of fireworks and this time of year, our office is authorized to issue an emergency restriction on sale and use pursuant to Snohomish County Code 30.53A.725 which states the following:

SCC 30.53A.725 Fireworks – Emergency restriction on sale and use. The fire marshal may prohibit the discharge of all fireworks during periods of extreme fire danger. The fire marshal may exempt a public display of fireworks form this prohibition by permit and upon a finding that the public display will not constitute an extreme fire danger.

During this time of year, our office keeps a very close eye on the fire danger conditions by utilizing multiple resources that include moisture content in vegetation, department of natural resources, etc. Currently Snohomish County is in a moderate fire danger. We are not currently in a high fire danger nor an extreme fire danger. Therefore, we will not be issuing an emergency ban on fireworks.

Though I understand the stress of fireworks and this time of year, our office is authorized to issue an emergency restriction on sale and use pursuant to Snohomish County Code 30.53A.725 which states the following:

SCC 30.53A.725 Fireworks – Emergency restriction on sale and use. The fire marshal may prohibit the discharge of all fireworks during periods of extreme fire danger. The fire marshal may exempt a public display of fireworks form this prohibition by permit and upon a finding that the public display will not constitute an extreme fire danger.

During this time of year, our office keeps a very close eye on the fire danger conditions by utilizing multiple resources that include moisture content in vegetation, department of natural resources, etc. Currently Snohomish County is in a moderate fire danger. We are not currently in a high fire danger nor an extreme fire danger. Therefore, we will not be issuing an emergency ban on fireworks.
