<u>Summary:</u> The ordinance approves template form agreements for the distribution of Stop the Bleed Kits throughout Snohomish County. Snohomish County has obtained Stop the Bleed Kits for installation at publicly accessible locations throughout the Seattle Urban Area Security Initiative (UASI) regions through a memorandum of Understanding with King County. The kits were provided at no cost to Snohomish County. Stop the Bleed encourages bystanders to become trained and equipped to help in a bleeding emergency before professional help arrives. Those nearest to someone with life threatening injuries are best positioned to provide first care.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
