Authority Granted: Authorize the Executive to execute the contract and any subsequent amendments.

Background: The Sixth Amendment of the United States Constitution states that the accused has the right to the assistance of counsel for their defense in criminal prosecutions. As not every defendant can afford an attorney, in 1989 Washington State implemented Chapter 409 (RCW 10.101) stating that "legal representation should be provided for indigent persons and persons who are indigent and able to contribute." This chapter also requires counties and cities to establish standards for the delivery of defense services to indigent defendants.

Since the enactment of RCW 10.101, the County has contracted with outside attorneys for legal services to indigent defendants through the courts, and then in 2000 under the Office of Public Defense upon its creation. Today, the largest contract is with the
