On Saturday evening 10/16 a (newer) neighbor decided to discharge fireworks while I was bringing my 3 horses into the barn for the night, at 8:30pm. Their backyard is separated from my barn by a very narrow backyard of another neighbor. My horses were just about to enter the barn, with me directly behind the last horse, when the "show" started. In their surprise and panic, I was knocked to the ground but avoided being trampled by rolling under a

fence. In the short breaks between discharges, I managed to get them into their stalls (it helps that they knew there was hay waiting), went outside to the front of the barn and literally screamed at the top of my lungs in-between discharges to STOP IT NOW. They didn't stop. My horses were very scared, this was far louder and closer than they are used to, not to mention I do alot of prep prior to EXPECTED fireworks (on 7/4 and 12/31) to mitigate noise and visuals (including tranquilizers). I quickly drove to the neighbors, and interrupted their party (yes, with my hair on fire....). The repercussions of this event is 1) my younger horse whose stall window (un-shuttered at the time) was exposed to the visual explosions, will not willingly go into her stall now, and panics when she is in it, (sadly a place where she used to feel the safest); and 2) I have a black-purple bruise and knot the size of a grapefruit on my hip. I could have been very badly hurt, or worse (BTW, I'm 65yrs old, have had horses for 53yrs, and at this home specifically for the past 28+yrs). ..."

"...And when trying to soothe a petrified, sweat-soaked, 1200lb horse with my arms around his neck, trust me.... it's hell. I haven't enjoyed a July 4 friends and family event at my home in 20yrs, as the pyro has gotten worse and worse. Celebrate the 4th? Not at my home....only celebration is when it stops. "

"Gosh, that was so dangerous to you and your horses. I'm so sorry that happened. You may already know, for unincorporated King County, our council passed a ban on fireworks this year to take effect in 2022. Two individuals shooting off mortars and rockets for hours, causing harm and terror thru our neighborhood of 100s of homes, full of families with new babies and seniors, pets and a few horses, tired and healing people, and many working diligently from home. On Saturday evening 10/16 a (newer) neighbor decided to discharge fireworks while I was bringing my 3 horses into the barn for the night, at 8:30pm. Their backyard is separated from my barn by a very narrow backyard of another neighbor. My horses were just about to enter the barn, with me directly behind the last horse, when the "show" started. In their surprise and panic, I was knocked to the ground but avoided being trampled by rolling under a fence. In the short breaks between discharges, I managed to get them into their stalls (it helps that they knew there was hay waiting), went outside to the front of the barn and literally screamed at the top of my lungs in-between discharges to STOP IT NOW. They didn't stop. My horses were very scared, this was far louder and closer than they are used to, not to mention I do alot of prep prior to EXPECTED fireworks (on 7/4 and 12/31) to mitigate noise and visuals (including tranquilizers). I quickly drove to the neighbors, and interrupted their party (yes, with my hair on fire....). The repercussions of this event is 1) my younger horse whose stall window (un-shuttered at the time) was exposed to the visual explosions, will not willingly go into her stall now, and panics when she is in it, (sadly a place where she used to feel the safest); and 2) I have a black-purple bruise and knot the size of a grapefruit on my hip. I could have been very badly hurt, or worse (BTW, I'm 65yrs old, have had horses for 53yrs, and at this home specifically for the past 28+yrs). ..."

"...And when trying to soothe a petrified, sweat-soaked, 1200lb horse with my arms around his neck, trust me.... it's hell. I haven't enjoyed a July 4 friends and family event at my home in 20yrs, as the pyro has gotten worse and worse. Celebrate the 4th? Not at my home....only celebration is when it stops. "

My name is Nadine Shanti and I am a resident of Snohomish County. In the past I have enjoyed fireworks to celebrate the fourth of July. This was BEFORE I truly understood the problems associated with their usage. The fires that have been caused by poor choices of individuals setting off fireworks in increasingly dry summers in our area are extremely concerning. I do not own any house pets, but I know firsthand of residents having to tranquilize their animals in order to get them through these celebrations. Some children are upset by the noise, but their parents are loathe to subject their children to tranquilizers.

My recent viewing of Seattle's New Year's Eve celebration marked a turning point for me. The smoke and air pollution was very evident in the portion of the event that was dedicated to fireworks. The laser presentation is a much more environmentally sound presentation. I realize that the Seattle production is a large scale presentation and we are speaking about individual usage here but it drives home the point that fireworks are counter intuitive to protecting air and water quality. That debris in our watershed areas of Snohomish County is destructive to the health of our numerous streams.

In addition to all of this evidence, the council really needs to deal with the issue of "Why we are selling something in areas where that usage is banned." I am on a heavily forested lot with Great Dane Creek running through it. People buy fireworks in areas where the usage is not allowed and then they come to neighborhoods where the residents don't want them and pollute the air, the streams and create NOISE pollution. There are more environmentally safe ways to celebrate our democracy.

I just signed off the Zoom webinar where you discussed fireworks. I couldn't figure out how to sign in so I could speak. I want to say that I am greatly disappointed at the seemingly "ho hum" attitude that I saw today. Councilman Low said something like, the subject of fireworks comes up now and then. This was totally dismissive of our plight.

When people shoot off fireworks in my neighborhood, I spend the whole time worrying about fire! I live in the UGA one mile west of the intersection of Filbert Road and Floral Hills cemetery. I live 1000 feet from Swamp Creek but am up on the hill. Much of this area is still heavily forested, which makes the problem very real and scary.

What we have here are houses five to ten feet apart. There are about 150 homes around my 3.5 acres of forest. I am **TERRIFIED** when people shoot off fireworks! The worst offenders are those who drink and light off fireworks. I have asked them to stop, but they don't. One of my neighbors rockets exploded about 3 feet above my patio. It left a burn mark on the patio even at that height. I was in the house and saw it out the window. This is why I can't go outside on the 4th of July! There needs to be consequences for this kind of law breaking.

I have to spend the whole 4th in the house. It's just awful. I can't go anywhere as I have to monitor my property for fire. It is very stressful. I am 82 years old and have lived here for 62 years. Shouldn't I be protected from such great fear in my older age? I hate the 4th of July!!! It is truly like a war zone during the 4th. How sad is that?!

There are 23 houses that back up to my property. It is a nightmare! If there is a fire, it could burn all up and down the corridor all the way to Kenmore and under or over I-405 which is about 1/4 mile from here. I'm not sure the people who live in the 17 homes behind my property on 12th Avenue would have access to get out if there is a fire, because of the way the road is set up. It's not just me that is at risk.

Don't we want trees to do all the good things trees do? Don't we want to protect homes and life? Don't we want little old ladies like me not to have to have to deal with so much stress?

Come On! You know that fireworks are a horrible thing in this crowded society! You know what happened in California with the fires! I just don't want to see the "Ho Hum" attititude that I saw today. I don't want you to pander to those who make a profit from fireworks and vote for you when you need to stand up and say "No more Fireworks. We are too crowded to continue this practice!

Please, please, please. Stop the sale of fireworks in the South County UGA. Actually, fireworks should not be allowed anywhere in our County. Many cities are banning fireworks. Do we not care what happens to our homes and forests and citizens in south county?

Oh my gosh! THIS IS A BIG DEAL! Please treat it as such! Please take action and stop the sale of fireworks in the South County Urban Growth Area at this time!

We attended the hearing on the use of fireworks. I see there is new activity regarding Ordinance 23-057 regarding banning the sale of fireworks in Snohomish County. I had the exchange below with Megan Dunn last year regarding this proposed ordinance. I was looking at the public testimony attached to the meeting details but did not see my correspondence included. Hello John,

Thank you for your input and respectful dialogue related to fireworks. I appreciate that you shared your views and your concerns. I have a few small corrections and wanted to share an update on where we are in this process. We have not passed this ordinance and would not do so without a public hearing and opportunity for residents to provide comment.

As you may know, it is illegal to set off fireworks in the Southwest Urban Growth Boundary, however, at this time the *sale* of fireworks is still allowed. Recently, Proposed Ordinance 23-057 was introduced by Councilmember Peterson to also prohibit the sales of fireworks in "no fireworks areas" where the use of fireworks are already prohibited. I am hopeful that this change will improve enforcement of the existing ban. I shared on social media about calling 911 and firework safety, but I'm not sure what you are referring to about a post attributed to me about ordinance 23-057.

I am supportive of making this change and I support this Ordinance but councilmembers had questions when this was discussed at the most recent Planning and Community Development Committee and the Ordinance did not move out of committee to be given a public hearing and final vote. We did hear comments about a modified ban that you mentioned and councilmembers asked to see examples of this, which is another reason why it did not move forward to allow time for research. So, council is considering this as an option or compromise and I would support this as well if it can be enforced properly.

This Proposed Ordinance will be discussed further at our July 18 Planning and Community Development Committee. Our code requires a public hearing and two week notification period and state law requires a one year delay before implementing any changes related to fireworks, so this timeline would put a ban on sales into effect late summer of 2024 and not until July 4th of 2025. Until this time, our Fire Marshall currently has the authority to ban fireworks during times of high fire risk.

You shared concerns about public input and transparency which is a value we share. The original ban was passed in 2019, prior to my term on council, and it was based on an advisory vote on the ballot that year, which showed strong support for a fireworks ban in south county. At the meeting on the 18th, our staff have put together a timeline of all the changes related to fireworks since the 1950s, that document will be in his staff report and it includes how/why the changes have occurred.

The proposed changes would require a public hearing, the agenda and topics are posted in the local paper and we require notice and open public comment during the hearing. We allow comment in person or remotely via zoom. Or written/mailed and emailed comment by email the full council at contact.council@snoco.org. If you have suggestions for improving transparency or notice I would be happy to propose changes in these areas to remove barriers or improve noticing.

I'm happy to answer any questions. Our agenda and staff report for the July 18th meeting will be posted on Friday by 4 pm, I'll try to forward this to you once I get it.

The difference however, is these citizens may now elect to purchase fireworks from the federally governed tribal neighbors which sell fireworks not meeting the "safe and sane" standard currently upheld by those retailers selling fireworks within Snohomish County. In addition, the thousands of dollars raised every year in tax revenues for Snohomish County by the sale of fireworks, would be distributed to neighboring federal lands and counties (Not to mention the local non-profit organizations that operate local retail operations would lose out on their longstanding annual fundraisers).

In lieu of banning fireworks and avoiding a real solution to the problems and concerns of those citizens who have appealed to the council to ban the use of fireworks in order to "provide them with firework safety protection," I propose we educate those citizens of Snohomish County who traditionally discharge fireworks, in the proper discharge and safety precautions required to protect all citizens of Snohomish County. After focusing on safety in the construction industry for multiple years in Olympia, it is very clear, the answer is not to remove privileges from the citizens and hope the concerns will resolve with time, but as seen in the construction industry over the past several decades, we need to address the issues head on with education.

I would be more than willing to volunteer and lead a committee focused on the education of the citizens of Snohomish County in the proper discharge and safety considerations when celebrating the birth of our nation. A few ideas for example include classes held several times each day during the operation of retail fireworks locations within Snohomish County which will permit and certify those citizens who would like to continue their tradition. This would allow only those willing to be educated to purchase common fireworks, providing real safety protection for all citizens of Snohomish County.

Please consider what is really needed for a remedy to the concerns of those citizens which have already appealed to the council for the ban of fireworks. Traditions still exist just like construction as a result of education and certification. Your time and consideration is very much appreciated in advance. Subject: Banning Sales of Fireworks - Unincorporated Snohomish County

I recently received the Fire District's newsletter and saw a reference to fireworks. I appreciate the efforts taken to ban discharging fireworks in unincorporated Snohomish County but additional steps are needed. When nearby cities banned fireworks, unincorporated Snohomish County became the "go-to" place to discharge fireworks even though we also have a ban for discharging fireworks. It's time for the County Council to ban discharging fireworks entirely and also ban the sale of fireworks in unincorporated Snohomish County for many reasons.

- Enforcement of the law for discharging fireworks is extremely difficult due to personnel shortages as
 well as the area of coverage. Catching violators is non-existent and with the interurban trail running
 through the area makes it even more difficult to apprehend offenders. The penalties if apprehended
 should be substantial. Considering the amount potential offenders pay for purchasing extravagant
 fireworks, the fines are small dollar amounts. The Council should consider banning the discharging of
 fireworks entirely.
- By allowing sales to occur in the unincorporated Southwest Snohomish County, a wrong message is
 being sent to the public--if it can be purchased in the area, it can be set off in the area. No matter the
 attempts to educate the public, it still sends a wrong message. People who are thrilled to discharge
 fireworks will travel miles to purchase so why not make it less convenient and remove sales entirely
 from the immediate neighborhoods in the County.
- In this time of climate friendly concerns for our environment, we need the County Council to address both discharging and sale of fireworks. Even though sale of fireworks is allowed by law during a specified window of time, it doesn't stop the purchaser from discharging fireworks.--it actually encourages it. The air quality from the time the fireworks stands open until days after the 4th of July is unacceptable. With the upcoming threat of wildfire season, air quality impacts and impact on responders, we need to do what we can to help the situation and controlling sale and discharge of fireworks is just one component.
- The impact of taxpayer funded resources (i.e., police, fire, and medical personnel) being used to address complaints, put out fires, and treat injuries can be reduced by banning fireworks discharging and sales. These responder system resources are already dealing with job stresses, workloads and lack of sufficient personnel.
- It's an overall safety issue of the community residents—personal property, injuries, Veterans with PTSD, mental health issues, caregivers, pets, and many other health concerns (asthmatics, COPD patients, etc.). We need to do whatever we can to keep our residents safe.

It's encouraging to hear that some cities (i.e., Kent) are banning fireworks and putting in place a drone show to be enjoyed by their residents. Why not use technology to have a display, be climate conscientious, and help our police, fire and medical personnel? Last year, the City of Seattle combined a firework display with a drone show and experienced complaints from the viewing public that the discharging of fireworks ruined the drone show due to smoke-filled skies, and preventing the full enjoyment of the drone display. That alone is a

testament to the air quality impact that is experienced for days afterward and it comes at a time in summer when air quality is already compromised by wildfires in Washington State and Canada.

There will be those who will argue it's their right to freedom of speech, but you can display your freedom and celebrate our country's independence with flags, ceremonies, parades and drone shows without the use of fireworks that destroy property, lives and the air we all breathe. There will also be the Native Americans who contend the sale of fireworks is a substantial source of revenue for them. They already have a means of diversified revenue (casinos) and tax exemptions offered by both Washington State and the Federal government. Instead, they could host the drone shows on the reservation and charge parking and admission fees. Cities like Lynnwood, Everett and Edmonds could ban together to put on drone shows for the public and this would be an option for residents of unincorporated Snohomish County to attend. It comes with a cost and that cost could be passed on to the residents who want to attend the displays by way of admission fees.

As a constituent, I strongly encourage the Council to **ban the sale and discharging of fireworks entirely in unincorporated Snohomish County**. You also have the ability to voice it at a state level with some of the Council members also serving in the Washington State House of Representatives. Take action to support your constituents and the communities you serve as an elected official.
