Background: This ordinance proposes to accept a statutory warranty deed and establish county road 188<sup>th</sup> PI NW through Lake Martha Development LLC. The proposed road will connect 86<sup>th</sup> Dr NW formerly (FKA) Warren Ave to the west and 85<sup>th</sup> Dr NW, FKA Horner Ave to the east.

## ORDINANCE NO. 21-021

## AN ORDINANCE ACCEPTING STATUTORY WARRANTY DEED AND ESTABLISHING COUNTY ROAD, 188th PI NW

Section 1. Adopts findings of fact.

- <u>Section 2</u>. Finding that Lake Martha Development LLC, intends to deed property described in Sections 6 for the use of the public in perpetuity and that a statutory warranty deed has been executed and submitted to accomplish the same.
- <u>Section 3</u>. Authorizes the Snohomish County Executive to accept the deed on behalf of Snohomish County.
- <u>Section 4</u>. Lake Martha Development LLC, constructed the road to County design standards at its own expense and will post a two-year maintenance security.
- <u>Section 5</u>. Finding that the proposed road right-of-way (ROW) are a public necessity, are practicable, and the public will be benefited by the establishment of 188<sup>th</sup> PI NW.
- <u>Section 6</u>. Provides the full legal description and establishes the roads as County road ROW subject to full County authority and discretion.
- <u>Section 7</u>. Establishment of County ROW is not effective until: (1) the Department of Public Works (DPW) files a certification with the Clerk of the Council stating administrative and advertising costs are paid.

At the hearing, the Council may also consider alternatives/amendments to the proposed ordinance.
