Although my formal educational background is in Business, my personal interest in the area of human rights has made me a lifelong student of history and the human condition and experience. This had led me to the study of social liberation movements (disability, gay, feminist, transgender, Black, Indigenous), the conditions from which they were borne, and the ways in which they have impacted policies, laws, and public discourse in pursuit of a more just human experience for all.
	My professional experience has included nearly ten years of work in real estate sales, appraisal and property management where I had the opportunity to work with people of various socioeconomic and cultural backgrounds. It also includes seven years of service in public employment where I learned about the value of the work being done by the many dedicated public servants in our communities, as well as the critical need for inclusive policies and practices (which are continuously reviewed, evolved, and improved) in support of that work. For example, many years ago I had the opportunity to serve on the King County Superior Court Human Resources Committee formed to create updated performance evaluation tools. This allowed me an opportunity to participate in a motivated group whose goal was to thoughtfully approach the creation of a more fair employee evaluation process.
	My formal education in various areas under the umbrella of Business Administration have taught me that not only are measures to increase workplace diversity necessary to comply with various laws and internal initiatives, but that it is a potential value creation boon for organizations in that it can facilitate innovation and opportunities in new markets or market

	I recognize that I will still have blind spots due to the layers of filters through which I, personally, experience the world. The only way to overcome this deficiency is to listen and learn from marginalized communities who are seeking support in upholding their human rights. I am a qualified candidate most of all because I am committed to this ongoing process of listening and learning.
Please list community involvement/volunteer activities	As a parent of four kids in public schools, I have been an ongoing advocate for policies and practices which uphold students' human rights and foster a positive educational environment. Some of the issues I have challenged our schools to improve upon include: raising awareness around the need for culturally sensitive and inclusive scripts for school plays, applying gender-neutral/race-neutral dress codes and staff training around this issue; student rights with regard to bathroom policies and improved staff training on students' right to utilize bathroom facilities when necessary; issues around exclusionary discipline policies; the need to make after school snacks available for student athletes of families who may have limited means; and fostering respectful and welcoming interactions from school staff toward all students during both in- school hours and after-school sports.
