## PROPOSED ORDINANCE NO. 21-094

RELATING TO THE 2021 BUDGET; MAKING A SUPPLEMENTAL APPROPRIATION TO PROVIDE EXPENDITURE AUTHORITY IN GENERAL FUND 002, HUMAN SERVICES FUND 124, LIMITED TAX DEBT SERVICE FUND 215, PARKS CONSTRUCTION FUND 309, FACILITIES CONSTRUCTION FUND 311, DATA PROCESSING FUND 315, SURFACE WATER MANAGEMENT FUND 415, AND INFORMATION SERVICES FUND 505 FOR PROCEEDS FROM THE SALE OF REAL PROPERTY

WHEREAS, Snohomish County Council approved Amended Motion No. 20-290 on August 12, 2020 authorizing the surplus and disposition of approximately 144.77 acres of County-owned General Fund real property known as the Cathcart West property (the "Property"); and

WHEREAS, Snohomish County publicly bid the property for sale and received multiple bid offers for the Property; and

WHEREAS, Snohomish County Council approved Motion 21-179 on May 12, 2021 authorizing the Real Estate Purchase and Sale Agreement between Snohomish County and Pacific Ridge – DRH, LLC, with a purchase price of \$40,320,000; and

WHEREAS, the property transfer has been completed and Snohomish County has received the proceeds from the sale.

NOW, THEREFORE, BE IT ORDAINED:

**Section 1.** The County Council makes the following findings of fact: a supplemental appropriation in the amount of \$78,480,000 is necessary for budget year 2021 to provide expenditure authority to pay off the associated debt and for investment in critical infrastructure projects.
