Josh Weiss, Gordon Thomas Honeywell, provided a detailed update on Snohomish County related Bills and priorities.

Mr. Weiss made Council aware of a letter they sent to Executive Somers that Senator Liias had specifically asked them to send regarding the Transportation Budget. He said they are not asking for Council's approval or signature, just wanted Council to be aware of content and tone.

Councilmember Dunn reported that she signed a letter of support for House Bill 1525 which expands childcare eligibility for apprentices. She said can send the letter to other councilmembers if there is interest. She said Economic Alliance also supported the letter, so she felt comfortable signing.

Ryan Countryman, Sr. Legislative Analyst, provided a staff report. He explained that the Department of Commerce is providing the County with an additional \$12,000,000 of American Rescue Plan Act (ARPA) dollars for COVID relief funding that can be used for low-income residents effected by the pandemic. He said there are no local matching requirements for this funding. Mr. Countryman explained the total amount of the supplemental appropriation and referred councilmembers to the written material linked to the agenda for further details.
