1. Ordinance 23-046, relating to use and possession of controlled or counterfeit substances or legend drugs; adding a new Chapter 10.49 SCC

Council Chair Mead opened the discussion and welcomed Snohomish County Sheriff Adam Fortney and Prosecuting Attorney Jason Cummings to the table.

Prosecutor Cummings and Sheriff Fortney spoke in strong support of the proposed ordinance.

Lengthy discussion ensued as Prosecutor Cummings and Sheriff Fortney, along with Sheriff Deputy Lars Teigen, responded to questions relating to the merits of the proposed ordinance, the LEAD (Law Enforcement Assisted Diversion) Program and the Office of Neighborhoods, data collection, the need for additional staff, the growing use of fentanyl, and the urgency to have an ordinance in place by July 1, 2023.

Additional discussion followed regarding the timing and process of scheduling the public hearing.

Council Chair Mead noted that there will be multiple opportunities next week for additional discussion on the matter.
