a. Ordinance 23-017, approving award of Port and Public Facilities District Funds through the American Rescue Plan Act (ARPA)

Jim Martin, Sr. Legislative Analyst, provided a staff report. He explained this ordinance approves and interlocal agreement with the Port of Edmonds in the amount of \$250,000.00 of Coronavirus Local Fiscal Recovery Funds. He spoke, briefly, to the support the funds would cover and stated the term of agreement is through December 31, 2023.

ACTION: Vice-Chair Nehring made a motion to set time and date for a public hearing for Wednesday, March 29, 2023, at the hour of 10:30 a.m. Councilmember Dunn seconded the motion and it carried unanimously.

Motion 23-099, approval of Professional Marketing Services with Ventures, for Small Business Innovation Assistance through the American Rescue Plan Act (ARPA)

Jim Martin, Sr. Legislative Analyst, provided a staff report and explained these services are designed to assist small businesses negatively impacted during the pandemic. He said the term of the agreement is through September 30, 2024, with the potential of one additional one-year term at the discretion of the County and the not-to-exceed amount is \$2,000,000.00.

ACTION: Vice-Chair Nehring made a motion to approve Motion No. 23-099. Councilmember Dunn seconded the motion.

James Henderson, Executive's Office, introduced Laura Fletcher, Executive Director of Ventures and stated they are excited to have her on board to implement this important program for small businesses across the county. Ms Fletcher thanked the Council. She explained, briefly, their qualifications and that they are excited for this opportunity.

Councilmember Dunn asked what the best way the Council can support their outreach for small businesses. Ms. Fletcher responded and explained open lines of communication.

The question was called for and the motion to approve Motion No. 23-099 carried unanimously.

c. Motion 23-087, approval of lease - Jackson House 1818

Pacific Avenue, Suites A and B, Everett, WA 98201

Deb Bell, Sr. Legislative Analyst, provided a staff report. She explained that the Auditor's Office currently uses this space and she spoke about the lease rates.

Ms. Bell responded to Councilmember Dunn regarding the Auditor's Office moving out of the space and the term and extensions of the lease.

ACTION: Vice-Chair Nehring made a motion to approve Motion No. 23-087. Councilmember Dunn seconded the motion and it carried unanimously.

d. Motion 23-092, approve and authorize the County Executive 2023-0197 to execute Amendment 1 to the Intergovernmental Services Agreement to provide Information Technology Services with Community Transit

Deb Bell, Sr. Legislative Analyst, provided a staff report. She provided background information and explained that this amendment will allow the Department of Information Technology to provide GIS imagery data to Community Transit for an additional annual revenue of \$13,125.00 or \$26,250.00 for the term of the existing agreement. The expiration date of the agreement is December 10, 2024.

ACTION: Vice-Chair Nehring made a motion to approve Motion No. 23-092. Councilmember Dunn seconded the motion and it carried unanimously.

e. Motion 23-091, confirming the appointment of Angie Sievers 2023-0211 to the Snohomish County Planning Commission

Ryan Countryman, Sr. Legislative Analyst, provided staff report. He explained that the Executive has nominated Ms. Seivers for this at-large position. Ms. Seivers is a resident of District 2 and has significant experience serving on other boards and commissions throughout the county. He said with this appointment, if approved, would bring the board back to full strength at 11 members.

ACTION: Vice-Chair Nehring made a motion to set time and date for a public hearing for Wednesday, April 5, 2023, at the hour of 9:00 a.m. Councilmember Dunn seconded the motion and it carried unanimously.
