Heidi Beazizo, Senior Legislative Analyst, provided an overview of the draft Plan for a total grant allocation of \$6,009,974 for affordable housing, community services facilities, infrastructure projects, homeless programs, and economic development activities. She noted that the 2022 program year runs from July 1, 2022, through June 30, 2023.
