### **CALL TO ORDER**

Committee Chair Dunn called the meeting to order at 10:00 a.m. and provided instructions for those wishing to provide public comment for both in-person and remote via Zoom.

### **ACTION ITEMS**

1. Motion 22-437, confirming the appointment of Robert Ogawa to the Snohomish County Human Rights Commission

Heidi Beazizo, Sr. Legislative Analyst and Interim Chief of Staff, provided a staff report, explaining the Human Rights Commission and gave background information on Captain Robert Ogawa. She Captain Ogawa would serve a term ending July 1, 2025.

Committee Chair Dunn asked if the Human Rights Commission supports the nomination, as they recommended a different candidate. Ms. Beazizo noted that the ECAF does not include a recommendation from the Commission.

Heidi Beazizo, Sr. Legislative Analyst and Interim Chief of Staff, provided a staff report on the proposed awards of Council project funds. Chair Dunn asked if all these proposals met all the funding requirements under ARPA and Ms. Beazizo answered affirmatively.

Heidi Beazizo, Sr. Legislative Analyst and Interim Chief of Staff, provided a detailed staff report. She explained that this motion directs the Treasurer to deposit \$4,652.82 to the General Fund as privilege tax revenue received from the Public Utility District.

Heidi Beazizo, Sr. Legislative Analyst and Interim Chief of Staff, provided a detailed staff report explaining the proposed budget transfer of \$320,000.00 into the Auditor's Election Services Program to cover unanticipated costs for elections.

 Motion 22-450, authorizing Snohomish County Executive to execute a 2023 work plan/financial plan with USDA-APHIS Wildlife Services 2022-1102

Heidi Beazizo, Sr. Legislative Analyst and Interim Chief of Staff, provided a detailed staff report and explained this plan reduces wildlife hazards to aircrafts. She further said \$175,508.96 covers the costs of a wildlife biologist for up to 40 hours per week, in addition to vehicles, equipment, supplies, and/or training.

Heidi Beazizo, Sr. Legislative Analyst and Interim Chief of Staff, provided a staff report discussing the reclassification of position AIR6380R from an Airport Operations Superintendent to an Operations and Security Division Manager. She said if approved, the pay grade will move from a 111 to a 113, an annual increase of \$27,246.72 at the top step.

Chair Dunn clarified that this is an open position.

Heidi Beazizo, Sr. Legislative Analyst and Interim Chief of Staff, provided a staff report explaining outside legal counsel representing the County on an issue related to the airport's runway has changed law firms. She further explained the proposal to transfer the contract from the attorney's prior law firm to the new law firm.
