Heidi Beazizo, Chief of Staff, provided a staff report. She explained that in order to balance 2022 and the Grant Work Plan funds expended, Human Services is requesting additional expenditure authority in the amount of \$15 million. She said this ordinance has no impact on the General Fund.

2. Motion 23-042, approve and authorize the County Executive to sign the Low-Income Home Energy Assistance Program Infrastructure Investment & Jobs Act (LIJA) Contract 23-3260i-081 with the Washington State Department of Commerce

Heidi Beazizo, Chief of Staff, provided a staff report. She explained that the Grant Work Plan did not include funds for the Low-Income Home Energy Assistance Program Infrastructure Investment & Jobs Act (LIJA) therefore Council consideration is requested, authorizing the completion of the agreement and receipt of the funds. She said the funds equal \$220,648.00 and the term of the agreement is October 1, 2022 through September 30, 2024.
