She also noted that if Council considers proposed Amendment 1, then the accompanying legislation, Motion 21-201, should also be considered in conjunction with the ordinance at the public hearing.

Councilmember Nehring suggested that Council defer scheduling a public hearing to provide Councilmember Low the opportunity to present information on the proposed Amendment 1.

Councilmember Mead recommended that the proposed Amendment 1 be introduced as a separate policy from Ordinance 21-033.

**ACTION:** Council Vice-Chair Dunn made a motion to schedule a public hearing to consider Ordinance 21-033 on Wednesday, June 16, 2021, at the hour of 10:30 a.m. Councilmember Mead seconded the motion and it carried unanimously by the four members present.
