Council Chair Wright opened the hearing and the clerk read the ordinance title into the record.

Geoffrey Thomas, Chief of Staff, provided a staff report. He summarized Amendments 1 through 3A and explained that Amendment 3A replaces Amendment 3. He explained that the amendments were added after public notice was issued and said it is recommended that Council continue the hearing and re-notice to include the amendments. There were no questions from councilmembers.

**ACTION:** Vice-Chair Dunn made a motion to continue Ordinance 21-018 to June 9th at 10:30 a.m. and to issue appropriate notice for the continued public hearing to include the amendments. Councilmember Mead seconded the motion and it carried unanimously.
