Nicole Gorle, Sr. Legislative Analyst, provided a staff report for both Motions 22-333 and 22-334. She stated the motions would approve change orders to the original contract. Motion 22-333 would approve Change Order 11 in the amount of \$485,000.00 for slide repair excavation and embankment and rock backfill. Motion 22-334 would approve Change Order 12 in the amount of \$657,206.00 for an additional 29,873 tons of material to be brought in to construct a new roadway. Ms. Gorle said there are sufficient funds in the 2022 Budget to cover the fiscal impact, which includes some federal highway emergency relief funds. She said the Executive recommends approval.

ACTION: Councilmember Low made a motion to approve Motion 22-334. Councilmember Wright seconded the motion and it carried unanimously by the three members present.
