Chair Dunn explained that Councilmember Nehring and she drafted this letter to help support nurses and are asking for support. Councilmember Nehring thanked Chair Dunn for working together on this letter. He spoke to the letter and thanked the nurses for their hard work. He also thanked Councilmember Rhyne from the city of Everett for helping to put this together. Chair Dunn said this letter has been sent to the city of Everett to see if they would consider signing on.

Councilmember Low thanked Chair Dunn and Councilmember Nehring for putting the together and expressed his support. Vice-Chair Mead and Councilcmember Peterson also voiced their support.

# **3.** Friendly Council Amendment Request - Sheriff's Office <u>2022-1100</u>

Ms. Beazizo explained that the friendly amendment request [2023 Budget] is to eliminate 20 unfunded FTE ghost positions from the Sheriff's Office and the Correction's Bureau, 10 in the Sheriff's and 10 in Corrections, that had been used for recruitment and hiring.

Chief Norm link, Sheriff's Office, explained that many years ago, the Sheriff's Office had ghost positions placed in the budget to help with administrative processing. He explained that those positions are not needed anymore and it is the Sheriff's request to eliminate those positions.

Chair Dunn said the Department came to her last week with this request and she said she wanted to bring to Council before moving forward at the request of the Department.

Ken Klein, Executive Office, stated that the Executive Office has no issues with this amendment.

Councilmember Low and Chair Dunn will bring this forward together as a standalone amendment. Chief Link made it clear that the positions have always been unfunded administrative positions and they never had funding attached to them.
