1. State Legislative Update - Gordon Thomas Honeywell

Lacey Harper, Executive Director, along with Stephanie Wright, Executive Policy Officer, and Josh Weiss and Annika Vaughn, Gordon Thomas Honeywell, presented the 2023 Draft Legislative Agenda to be discussed at the upcoming Legislative Lunch - Special Meeting on December 5, 2022.

Discussion followed as staff responded to questions relating to the proposed legislative agenda.

Councilmembers expressed concerns regarding proposals to deal with behavioral health, public safety, and housing impacts resulting in the State v. Blake court ruling. Councilmembers also noted concerns regarding the budget requests and the use of public funds for the proposed Everett Multi-Use Sports Complex.
