PURPOSE: The purpose of this task assignment with GeoEngineers, Inc. is to assist on the Building C-1 (Precision/ATS) Site Remedial Investigation Planning & Implementation.

BACKGROUND: .

- The Airport requests authority to utilize the Snohomish County Public Works On-Call Contract for environmental consulting services.
- GeoEngineers, Inc. ("GeoEngineers") of Seattle was selected to provide environmental consulting services pursuant to the Snohomish County Public Works On-Call Contract Agreement No. OCC23/2-7.8(U).
- GeoEngineers previously provided environmental consulting services on the former Precision/ATS lease area.
- Precision vacated the premises and left an undetermined amount contamination that needs further
