PURPOSE: Executive approval of Amendment(4) to the PSTAA Interlocal Agreement with Everett Public Schools to reallocate unspent funds from ILA Budget 2022-2023 to ILA Budget 2023-2024.

BACKGROUND: The PSTAA ILA Amendment(3) included the 2023-2024 Services and Expenditure Plan for \$331,658.04. The PSTAA ILA Amendment(4) reallocates unspent PSTAA funds from 2022-2023. This ILA amount is increased by \$114,583.13 for a new ILA amount of \$446,241.17. Ordinance 22-072 authorizes the executive to execute amendments to the annual services and expenditure plans that reallocate unspent funds from a prior program year and for which sufficient appropriations already exist.
