PURPOSE: APPROVAL OF THE AGREEMENT BETWEEN SNOHOMISH COUNTY AND SNOHOMISH HEALTH DISTRICT FOR CORONAVIRUS LOCAL FISCAL RECOVERY FUNDS

BACKGROUND: Snohomish County Council authorized \$2.5M for payment of premium pay in Amended Ordinance 21-035. The County wishes to provide up to \$150,000 of Coronavirus Local Fiscal Recovery Funds (CLFR) grant funding to the Snohomish Health District for Premium Pay to the Snohomish Health District’s qualified employees.
