**PURPOSE:** Approval and execution of an Interlocal Agreement between Snohomish County and the Silver Lake Water and Sewer District for Utility Construction associated with the 43<sup>rd</sup> Ave SE Road Project which will allow the County to perform services on behalf of Silver Lake Water and Sewer District.

**BACKGROUND:** The Department of Public Works (PW) intends to improve 43<sup>rd</sup> Ave SE/Sunset Rd between SR 524 and 180<sup>th</sup> Street SE east of the Mill Creek city limits, in unincorporated Snohomish County. The County is the lead agency for the road project. Silver Lake Water and Sewer District holds a franchise for occupancy of public road rights-of-way and is required, as a condition of its franchise and state law, to relocate its facilities at its own expense to accommodate public road improvements. Silver Lake Water and Sewer District has requested the County incorporate construction and relocation of water lines and associated utility work in the project vicinity into the County's construction contract. All costs associated with the utility work will be paid by Silver Lake Water and Sewer District. RCW 39.34, the Interlocal Cooperation Act, authorizes governmental cooperation between public entities to provide services and facilities in a manner that will best
