**PURPOSE:** Approve Interlocal Agreement to provide funding to the City of Marysville for development of Olympic View park

**BACKGROUND:** Snohomish County Council approved Amended Ordinance 20-071 on November 10, 2020 to adopt the 2021 - 2026 Capital Improvement Program (CIP), which included funding for the City of Marysville Olympic View park development project. This project is planned to provide a plaza, picnic shelter, restrooms and off-street parking. The City has provided a written request to receive the funds and has agreed to the terms of the Interlocal Agreement. Funding provided from the County to the City will be in the amount of \$25,000 subject to the terms of the agreement.
