#### **EXECUTIVE RECOMMENDATION:** Neepaporn Boungjaktha (12/6/22)

**PURPOSE:** Approval of mutual termination of legal professional services agreement with Cozen O'Connor and new legal professional services agreement with Stokes Lawrence, P.S. to represent the County for runway recovery.

### BACKGROUND: .

- By Motion No. 19-211, the Snohomish County Council approved and authorized the County Executive to sign a Contract for Legal Services between Snohomish County and Cozen O'Connor for recovery of damages claims at the Snohomish County Airport.
- The primary attorney representing the County at Cozen O'Connor has changed law firms and requests the existing contract be transferred to his new law firm, Stokes Lawrence, P.S.

- The current law firm Cozen O'Connor agrees to the transfer of the matter to Stokes Lawrence, P.S. and to the mutual termination of its current contract with the County.
- It is in the best interests of the County to mutually terminate the existing Contract for Legal Services with Cozen O'Connor and enter a new Contact for Legal Services with Stokes Lawrence, P.S. to continue with the same attorney representation and upon the same terms as the contract with Cozen O'Connor.
