The errors, omissions, and inconsistencies identified for correction in this ordinance include (i) grammatical and typographical errors, (ii) outdated or inaccurate citations and cross-references, and (iii) missing language that was accidentally deleted or omitted during previous amendments

BACKGROUND: This ordinance is necessary to correct certain inadvertent errors in title 30 SCC which cannot be addressed by the county code reviser through the authority in SCC 1.02.020(2).
