**PURPOSE:** To provide mandated legal defense services in cases that are a conflict of interest to the County’s contract with the Public Defender Association (PDA) for the period from June 1, 2023 to December 31, 2023, with a potential for two (2) additional one (1) year extensions.

**BACKGROUND:** This contract covers cases that are a conflict of interest to the PDA. The case types covered under this contract can include as noted on the contract Misdemeanors, Class, A, B, and C Felony cases, Expedited Felonies, Juvenile criminal charges, Miscellaneous Superior court case types, RALJ (appeals from District court to Superior court), Civil protection orders, and Child Dependency cases. \$250,000 is the NTE amount for 2023 as the case type, duration, and other factors affecting caseloads are unknown at this time. These factors emerge throughout the year and OPD will manage contracts with these attorneys as needed.
