PURPOSE: To provide annual Snohomish County Public Facilities District Compliance Certification letter for the year ending 2021.

BACKGROUND:.

- → Snohomish County and the Snohomish County Public Facilities District ("PFD") entered into an Interlocal Agreement for the development of a regional center at Paine Field on December 17, 2003.
- Addendum # 1 to the Interlocal Agreement provided for allocation of excess revenue collected by the PFD ("Aggregate Tier 2 Allocations") and was signed on March 2, 2009.
- Addendum # 2 to the ILA created additional aggregate Tier 2 allocations for each respective PFD and was signed on January 20, 2020.
- Addendum #1 Section 5 titled Annual Compliance Certification requires the County to provide written
