The Board meets monthly and is comprised of up to 15 members, drawing from all areas of the county and a range of backgrounds, including family members, individuals with developmental disabilities, professionals and advocates. \*John Wennberg resides in Council District 4. \*Mr. Wennberg is an active disability rights advocate and a former board member from 2002 to 2010. \*Mr. Wennberg will bring his personal perspective and years of experience to the board as an individual with a disability, a successful business owner and public speaker. \*This will be Mr. Wennberg's 2<sup>nd</sup> term, ending 5/2/2024. \*The Snohomish County Developmental Disabilities Citizen Advisory Board currently has 8 members and 7 vacancies. \*Mr. Wennberg does not serve on any other County Board or Commission.
