BACKGROUND:

File #: 2021-0320, Version: 1

- Snohomish County has awarded the construction contract for the Index-Galena Road Flood Repair Milepost 6.4 6.9.
- US Forest Service (USFS) has granted an easement for a relocated section of roadway across National Forest System lands containing approximately 2,400 trees within the easement area.
- In order to complete the project, the County will need to remove approximately 2,000 trees belonging to USFS.
- The County and USFS entered into a Purchase and Sale agreement totaling \$87,196.38 on March 11, 2021 to purchase and remove timber within the easement area.
- During the timber removal process the County and USFS may identify additional and deletion tree volume at the
 project site. Deletion volume will be credited back to the County after all timber has been felled.
- In the event the County and USFS identify additional tree volume that were not included under the original
 agreement, the costs associated with the additional timber must be paid to USFS before it can be removed from the
 project site.
- A supplement has been negotiated with USFS for an additional \$10,000 to be used on an as-needed basis should the County be required to make additional payments to USFS for additional tree volume.
