Motion 21-168, authorizing the County Executive to sign Supplement No.18 to Professional Services Agreement CCF07-13 with WSP USA, INC. to provide Consulting Services for the Index Galena Road (MP 6.4-6.9) Flood Repair Project

**PURPOSE:** Approval of Supplement No.18 will allow Public Works to continue working with WSP USA, Inc. to provide the necessary Engineer-of-Record Construction Support Services for the Index Galena Road Flood Repair Project.

### BACKGROUND:

- The Department of Public Works (PW) is under contract with a contractor to reconstruct one mile of Index-Galena road between Index and Skykomish to restore access to the upper North Fork of the Skykomish River. The project includes a 180' single span bridge, rock cutting and blasting, an armored box culvert, reinforced slopes, retaining walls, asphalt pavement and 14 acres of select logging.
- The construction is expected to continue for three years from April 2021 through October 2023 and will require support from the engineer-of-record during construction including structural engineering, geotechnical engineering, and surveying support. WSP is the engineer-of-record for the construction bid package with Shannon & Wilson providing professional geotechnical reports and Sills & Hill as the licensed surveyor for the project.
- The Emergency Relief Program from the Federal Highway Administration (FHWA) is funding 86.5% of project design and construction costs. The remainder of the cost is funded with County Road funds.
- PW selected the consulting firm, BergerABAM, which is now WSP USA, Inc. using applicable Federal, State and County policies and practices. The initial agreement was approved by Council in August of 2013, for \$1,237,640, and included a \$100,000 contingency fund.
- Since that time seventeen (17) supplements have been executed to provide additional but related services. Fifteen (15) within the Council approved contingency amount, and two (2) approved by Council.
- This supplement provides additional consultant services including construction related design services, RFI review, change order review, bridge load ratings, construction observation, geotechnical support services, construction staking and surveying services.
- Total payments for services under this supplement shall not exceed \$1,158,328.00, for an amended total amount not to exceed \$4,140,419.00.
