**BACKGROUND:** Snohomish County Council approved Amended Ordinance 20-071 on November 10, 2020 to adopt the 2021 - 2026 Capital Improvement Program (CIP), which included funding for the City of Granite Falls Jim Holm Park Improvement project. This project is planned to provide basketball court improvements at this City owned facility. The City has provided a written request to receive the funds and has agreed to the terms of the Interlocal Agreement. Funding provided from the County to the City will be in the amount of \$25,000.00 subject to the terms of the agreement.
